In 1991, the first Corporate Achievement Awards were held in San Francisco, CA. For 30 years, OCA has been honored to recognize Asian Americans and Pacific Islanders (AAPIs) for excellence, achievement, and leadership in the corporate sector. Each year, companies have an opportunity to nominate one of their own AAPI employees for their accomplishments and con-tributions. Recipients are chosen for recognition through their demonstration of leadership and commitment to the company and their commitment and dedication to the AAPI community.

Ms. Ginny Gong is an accomplished educator, a frequently requested speaker/facilitator/trainer, an experienced public administrator, a talk show host, an author, and a highly respected community leader at both the local and national levels.

Ms. Gong is president of The Gin G Group, an organization focused on career development through coaching and mentoring and helping immigrant families with acculturation and inter-generational relations.

In 1998, Ms Gong was the first Asian American appointed to head an agency in Montgomery County, MD and is credited with establishment of the first New Americans Welcome Center serving the County's diverse immigrant community. Prior, Ms. Gong was a teacher/administrator in school systems for more than two decades and a manager/trainer of system-wide diversity/compliance programs. Ms. Gong is host of the award winning weekly TV talk show series "Ginny's...where East meets West", currently in its 23rd year.

Ms Gong's recognitions include being: nominated to the Maryland Women's Hall of Fame, featured as one of Maryland's distinguished "Women Leading the Way" by MD Dept of Education, selected as the recipient of the "Women of Achievement Award" by MC Assoc of Business and Professional Women, recognized with the "Leadership Award" by MD State Education Association, and named as one of "10 Legendary Women Who Changed the Face of Maryland" by Maryland Life Magazine and the Maryland Women's Heritage Center.

A significant part of Ms. Gong's community involvement has been her more than 39 years of commitment to OCA for which she served 4 terms as its National President. Ginny is the proud mother of three grown children and four grandchildren.

2021 HONOREE Arun Mukherjee

Beyond sitting on OCA's Business Advisory Council, T-Mobile launched an External Diversity and Inclusion Council that created yet another channel of communication directly between civil rights groups and the company, including OCA. During this time Farni led the ERG to deliver results in all four areas of focus – Company, Community, Career and Culture.

During her tenure OASIS significantly increased membership and employee engagement. Under her leadership, OASIS held several cultural events at Sprint to highlight the rich cultures of Asia. These events provided great opportunities for our ERG members and employees to experience a taste of a broad and beautiful cultures, their art, history and diversity. During these events employees had an opportunity to hear from Sprint leaders about the importance of our ERGs and member engagement, while enjoying ethnic culinary treats and entertainment. For example, employees and guests had a chance to sample food from China and India and enjoy live performances from Indian, Malaysian, Bollywood, Chinese dancers/performers and even a Qipao Fashion show.

Farni ensured these gatherings included a robust agenda, including attendance and participation from some of our community partners such as the National Association of Asian Professionals (NAAAP), the Mid-America Cultural Association (MAACA) and the Singapore Club. As of April 2020, on occasion of the T-Mobile/Sprint Merger, Farni was selected as the Co-Lead for APAN (Asian & Pacific Islander-focus subgroup within new T-Mobile's Multi-Cultural Alliance Network.

Specifically for the Asian community, she partnered with our Asian Employee Resource Group, various internal and external communications teams, public policy group, various marketing groups, as well as business leaders to develop the strategy and execute robust programming around Asian Pacific American Heritage Month celebration, Lunar New Year programs, Diwali celebration, and more. As a result, they have achieved a constantly high Net Promoter Score for these programs, elevated understanding of the success and challenges of different communities, and enabled collaboration and innovation among our diverse employee groups. A few verbatim quotes from participants in the D&I culture programs she created:

• "The company gets it. They are not simply going through the motion to say 'we have that too.' It is an all-in way of showing how differences bring out the best of everyone."

• "I feel Verizon is being more open to letting people be who they actually are and accepting of people that are not the 'norm' in society."

• "It's easy in 2019 to feel marginalized and afraid to be who you are. I now feel reinvigorated and empowered - not only do I belong here but I am appreciated."

Quinnie has received many "Recognizing You" awards from peers and leaders across the company for going above and beyond to deliver. She was recognized, twice, by the company's Chief Marketing Officer at marketing town halls during her first job at Verizon, launching the company's first-ever Marketing Academy for thousands of marketing employees. She was also recently recognized by our Chief HR Officer for her leadership of a 20+ member cross-functional team to strategize, plan, and execute on their diversity partnership, Anita Borg/Grace Hopper Conference attracting female, diverse tech talent for the company.

Frank Wu

Frank H. Wu was named president of Queens College, The City University of New York (CUNY), effective July 2020. Wu previously served as chancellor and dean, and then William L. Prosser Distinguished Professor at University of California Hastings College of the Law in San Francisco.

Wu was appointed by the United States Department of Education (USDOE) to its National Advisory Committee on Institutional Quality and Integrity (NACIQI), which advises the administration on higher education accreditation, serving for nine years, including as vice chair; and by the U.S. Defense Department to the Military Leadership Diversity Commission, which submitted to Congress the report From Representation to Inclusion. Wu served on the board of the Leadership Conference on Civil Rights Education Fund. Members of the Committee of 100--a by-invitation nonprofit group of extraordinary Chinese Americans dedicated to promoting positive U.S.-China relations and the civic participation of Chinese American--elected him the organization's chair and subsequently its first president, a role he held for two and a half years.

Wu is the author of Yellow: Race in America Beyond Black and White, which was immediately reprinted in hardcover, and co-author of Race, Rights and Reparation: Law and the Japanese American Internment, which received the single greatest grant from the Civil Liberties Public Education Fund. Wu has maintained an extensive schedule of media appearances and public speaking. His professional credits include commentary for National Public Radio and "Now" with Bill Moyers. He has appeared as a guest on the "Oprah Winfrey Show," "O'Reilly Factor," and C-SPAN "Booknotes" with Brian Lamb. He has won the John Hope Franklin Award and the Chancellor Chang-Lin Tien Award, among other honors.
